AN ORDINANCE AMENDING ORDINANCE NO. O-17326 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17326-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF THE ENGINEERING AND DEVELOPMENT DEPARTMENT (540) TO DELETE ONE (1.00) ASSISTANT CIVIL ENGINEER AND ONE DEPUTY (1.00) DEPUTY DIRECTOR POSITION AND ADD IN LIEU THEREOF TWO (2.00) ASSISTANT DEPUTY DIRECTORS; EXEMPTING SAID ASSISTANT DEPUTY DIRECTORS FROM THE CLASSIFIED SERVICE; AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, the Engineering and Development Department is reorganizing by combining the existing functions of the Support Services Division into the existing Transportation Design and Field Engineering Divisions; and

WHEREAS, the existing Support Services Deputy Director position will be reclassified to Assistant Deputy Director and assigned to the Transportation Design Division; and

WHEREAS, the Assistant Civil Engineer position in the Field Engineering Division will also be reclassified to Assistant Deputy Director; and

WHEREAS, the two Assistant Deputy Director positions will provide a management team in each of the two divisions that will facilitate managing the large, diverse operations; and

WHEREAS, the positions have significant management level responsibilities which fall within the managerial definition contained in Charter section 117(a)17, justifying exemption from the classified service; and

WHEREAS, the Civil Service Commission reviewed this request on December 14, 1989 and has commented favorably upon the exemptions as meeting the criteria set forth in the Charter; and

WHEREAS, this action will amend the appropriation ordinance to substitute the new positions in the budget and exempt them from the classified service; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17326 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17326-1, as amended and adopted therein, by amending the personnel authorization of the Engineering and Development Department (540), to delete one (1.00) Assistant Civil Engineer and one (1.00) Deputy Director position and add in lieu thereof two (2.00) Assistant Deputy Director positions.

Section 2. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on December 14, 1989, the new Assistant Deputy Director positions in the Engineering and Development Department (540), be and they are hereby exempted


from the classified service and declared to be in the unclassified service of The City of San Diego.

Section 3. As a schedule of compensation for the above unclassified positions recited in sections 1 and 2 hereof, the salary rate set forth in Salary Rates 7.3, 7.4, 7.5 and 7.6 of the Table of Classifications and Standard Salary Rates under Managerial Category B, contained in Exhibit C to Ordinance No.O-17308 (New Series), be and the same is hereby adopted.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.


