AN ORDINANCE INCORPORATING 17,460± SQUARE FEET LOCATED AT THE NORTHWEST CORNER OF THE INTERSECTION OF NAVAJO ROAD AND LAKE MURRAY BOULEVARD, IN THE NAVAJO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM CP TO CO ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0423, AND REPEALING ORDINANCE NO. 8887 (NEW SERIES), ADOPTED SEPTEMBER 19, 1963, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That 17,460± square feet, located at the northwest corner of the intersection of Navajo Road and Lake Murray Boulevard, in the Navajo Community Plan area, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-3953, filed in the office of the City Clerk as Document No. 17417, be, and it is hereby incorporated into CO Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0423.

Section 2. That Ordinance No. 8887 (New Series), adopted September 19, 1963, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this

ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
