guidelines for the Grant Hill Park Historic District, is hereby
approved, amending Ordinance No. 00-16893-2, said Sherman Heights

and Grant Hill Park Historic Districts Design Criteria and Guidelines is on file in the office of the City Clerk as Document No. 00-17419

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


