AN ORDINANCE AMENDING THE SHERMAN HEIGHTS
HISTORIC DISTRICT DESIGN CRITERIA AND
GUIDELINES, ORDINANCE NO. OO-16893-2.

WHEREAS, on January 23, 1990, the Council of The City of San Diego held a public hearing for the purpose of considering amendments to the Sherman Heights Historic District Design Criteria and Guidelines, Ordinance No. OO-16893-2; and

WHEREAS, the Historical Site Board of The City of San Diego held a public hearing on February 24, 1988, to consider the designation of the Grant Hill Park Historic District and approved said designation; and

WHEREAS, the Sherman Heights Historic District and the Grant Hill Park Historic District are contiguous and are located in the Southeast San Diego Community; NOW, THEREFORE,


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the amendment of the Sherman Heights Historic District Design Criteria and Guidelines, to become the Sherman Heights and Grant Hill Park Historic Districts Design Criteria and Guidelines and to include development criteria and guidelines for the Grant Hill Park Historic District, is hereby approved, amending Ordinance No. OO-16893-2, said Sherman Heights

and Grant Hill Park Historic Districts Design Criteria and Guidelines is on file in the office of the City Clerk as Document No. 00- 17419.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
