Section 3. Projects permitted under Planned
Residential Development Permits, Planned Commercial
Development Permits, or Conditional Use Permits
approved prior to the effective date of this ordinance
may develop in accordance with the provisions of the
approved permit; provided, however, that any requested
amendments to approved permits shall be subject to the
provisions of this ordinance.

Section 6. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance except as provided in Section 3 shall be issued unless application therefore was made prior to October 17, 1989, the introduction date of this ordinance.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage,
