AN ORDINANCE AMENDING ORDINANCE NO. O-17326 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. OO-17326-1, AS AMENDED AND ADOPTED THEREIN, BY INCREASING THE GENERAL SERVICES DEPARTMENT'S COMMUNICATION AND ELECTRICAL DIVISION GENERAL FUND AND INCREASING THE GENERAL FUND REVENUE ESTIMATES FOR THE PURPOSE OF INSTALLING STREET LIGHTS IN HIGH CRIME AREAS.


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17326 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-17326-1 as amended and adopted therein, by increasing the General Services Department's Communications and Electrical Division General Fund by \$25,000 and increasing the General Fund revenue estimates by \$25,000 to account for reimbursement from CIP No. 68-012.0.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant

to the authority contained in Sections 16, 17 and 71 of the
Charter of The City of San Diego.


