AN ORDINANCE AMENDING ORDINANCE NO. O-17326 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17326-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF COUNCIL DISTRICT 5 (025) BY ADDING THERETO TWO (2.00) COUNCIL REPRESENTATIVE II POSITIONS; EXEMPTING SAID COUNCIL REPRESENTATIVE II POSITIONS FROM THE CLASSIFIED SERVICE; ESTABLISHING A SALARY RATE THEREFOR; AND AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER \$26,800 FROM THE UNALLOCATED RESERVE (605) TO COUNCIL DISTRICT 5 (025) TO FUND THE TWO POSITIONS.

WHEREAS, Council District 5 has requested the addition of two (2.00) Council Representative II positions to its fiscal year 1990 budget; and

WHEREAS, it was also requested that the positions be exempted from the classified service; and

WHEREAS, the positions have significant management level responsibilities which fall within the managerial definition contained in Charter section 117(a)17 and justifies exemption from the classified service; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the classified service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on December 14, 1989 and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, this action will amend the appropriation ordinance to add the new positions in the budget, exempt them from the classified service and establish a rate of pay therefor; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17326 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17326-1, as amended and adopted therein, by amending the personnel authorization of Council District 5 (025) by adding two (2.00) Council Representative II positions.

Section 2. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on December 14, 1989, the new Council Representative II positions be and they are hereby exempted from the classified service and declared to be in the unclassified service of The City of San Diego.


Section 3. As a schedule of compensation for the above unclassified positions recited in sections 1 and 2 hereof, the salary rate set forth in Salary Rates 7.3, 7.4, 7.5 and 7.6 of the Table of Classifications and Standard Salary Rates under

Managerial Category B, contained in Exhibit C to Ordinance No. O-17308 (New Series), be and the same is hereby adopted.

Section 5. That the Auditor and Comptroller be and he is hereby authorized to transfer within the General Fund 100 the sum of \$26,800 from the Unallocated Reserve (605) to Council District 5 (025) for the sole and exclusive purpose of funding said new positions and other costs associated therewith.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.


