AN ORDINANCE AMENDING ORDINANCE NO. O-17326 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17326-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF COUNCIL DISTRICT 6 (026) BY ADDING THERETO ONE (1.00) COUNCIL REPRESENTATIVE II POSITION; EXEMPTING SAID COUNCIL REPRESENTATIVE II POSITION FROM THE CLASSIFIED SERVICE; ESTABLISHING A SALARY RATE THEREFOR; AND AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$25,000 FROM THE UNALLOCATED RESERVE (605) TO COUNCIL DISTRICT 6 (026) TO FUND SAID POSITION.

WHEREAS, Council District 6 has requested the addition of one (1.00) Council Representative II position to its fiscal year 1990 budget; and

WHEREAS, the City Council approved this request in concept by Resolution No. R-274758, dated November 20, 1989 and directed that the funds for said position be allocated from the Unallocated Reserve; and

WHEREAS, it was further requested that this position be exempted from the classified service; and

WHEREAS, the position will have significant management level responsibilities which falls within the managerial definition contained in Charter section 117(a)17 and justifies exemption from the classified service; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the classified service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on December 14, 1989 and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, this action will amend the appropriation ordinance to add the new position in the budget and exempt it from the classified service; and

WHEREAS, this ordinance further authorizes the Auditor and Comptroller to transfer the sum of \$25,000 from the Unallocated Reserve (605) to Council District 6 (026) to fund said position; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17326 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17326-1, as amended and adopted therein, by amending the personnel authorization of Council District 6 (026) by adding one (1.00) Council Representative II position.

Section 2. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on December 14, 1989, the new Council Representative II position be and it is hereby exempted from the classified service and declared to be in the unclassified service of The City of San Diego.

Section 3. As a schedule of compensation for the above unclassified position recited in sections 1 and 2 hereof, the salary rate set forth in Salary Rates 7.3, 7.4, 7.5 and 7.6 of the Table of Classifications and Standard Rates under Managerial Category B, contained in Exhibit C to Ordinance No. O-17308 (New Series), be and the same is hereby adopted.

Section 4. That the Auditor and Comptroller be and he is hereby authorized to transfer within the General Fund 100 the sum of \$25,000 from the Unallocated Reserve (605) to Council District 6 (026) for the sole and exclusive purpose of funding said new position.

Section 5. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.

This ordinance amends the annual budget by amending the personnel authorization of Council District 6 (026) by adding one (1.00) Council Representative II position. The ordinance also exempts the new position from the classified service and sets a salary rate for said new position. The ordinance also transfers the sum of \$25,000 from the Unallocated Reserve (605) to Council District 6 (026) to fund said position.
