AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 3, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 63.20.5 RELATING TO BEACH FIRE RINGS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 3, of the San Diego Municipal Code be and the same is hereby amended by amending Section 63.20.5, to read as follows:

## SEC. 63.20.5 SAME - WASTE, REFUSE, ETC. - FIRES

- (a) and (b) No change.
- shall be unlawful for any person to build, maintain or use a fire on any public beach. In this subsection, the word "use" shall include being present within ten (10) feet of a fire. Fires may be built in a City-provided fire container using fire materials that are limited to charcoal, wood or paper products, none of which contains landscape debris, cloth, rubber, metal, asphalt, foam rubber, plastic or any similar matter or material producing noxious fumes, odors, smoke or leaving any type of solid residue other than ash. Fire materials shall not exceed a height of more than twelve (12) inches above the upper edge of the fire container and must be wholly contained within the inside edge of the

fire container. It shall be permissible to build a fire on a public beach in a portable barbecue or other similar device using fuel material authorized in this subsection. Coals from any portable barbecue or similar device shall either be removed from the beach area or be deposited in a City-provided fire container or designated hot coal container provided on the beach for such purpose.

- (d) It shall be unlawful to use a City-provided fire container for any purpose other than the building of fires for cooking or warmth or for the deposit of coals provided for in subsection (c).
  - (e) No change.
- shall be unlawful for any person who has built,
  maintained or used a fire on the beach to abandon
  such fire until all ignited fire fuel material has been
  exhausted or extinguished. In this subsection, the word
  "used" shall include having been present within ten (10)
  feet of the fire. Sand, dirt or similar material shall
  not be employed as an extinguishing material.
  Extinguished ashes shall not be covered but may be left
  in fire containers. All unused fire material shall be
  removed from the beach and the adjacent areas of the
  beach or park. All refuse or rubbish adjacent to the
  fire container site shall be removed from the beach or
  placed in trash cans or receptacles provided for such

purpose, so that the beach is left in a clean, sanitary and presentable condition.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

## ORDINANCE NUMBER O-17434 (NEW SERIES) ADOPTED ON FEB 26 1990

AN ORDINANCE AMENDING CHAPTER VI. ARTICLE 3, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SEC-TION 83.20.5 RELATING TO BEACH FIRE RINGS.

This ordinance amends San Diego Municipal Code section 83.20.5(c) by making it uniawful to build, use or maintain a fire on a public beach, except as is provided by ordinance. The revisions extend and clarify the former prohibitions and restrictions applicable to building fires on the beaches and make it clear that fuel material must not extend more than 12 inches above the top nor extend beyond the edges of a fire container. Fire materials are limited to wood, charcoal and paper. Other fuel materials which produce noxious amoke, fumes or odors, such as plastic, rubber, foam rubber, cloth, for which contain asphall or metal, are prohibited. Provisions are made to allow fires in portable barbecues under specified conditions.

Subsection 63.20.5(d) is amended to make it unlawful to use a City-provided fire container for other than the building of fires for cooking or warmth or the deposit of coals.

Subsection (f) is added to make it unlawful to abandon a fire without extinguishing it, and that extinguished fire material is to be left in the fire container without covering it with sand. Sand or dirt is not to be used to extinguish a fire.
