AN ORDINANCE REZONING PROPERTIES IN THE SOUTHEAST SAN DIEGO PLANNED DISTRICT FOR THE PURPOSE OF PRESERVING SINGLE FAMILY AND SPECIAL CHARACTER MULTI-FAMILY NEIGHBORHOODS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Within that area bounded by 36th Street and Olivewood Terrace to the west, by 37th Street to the east, by Oceanview Boulevard to the north, and by Logan Avenue on the south as shown on Map B-3944, are hereby rezoned from MF-3000 to SF-5000.

Section 2. Within that area bounded by 36th Street to the west, by 41st Street to the east, by the alley separating Florence Street and Logan Avenue to the north, and by the alley separating Logan Avenue and National Avenue to the south as shown on Map B-3944, be hereby rezoned from MF-1500 to MF-3000.

Section 3. Within that area bounded by 30th Street to the west, by San Diego Arizona Railroad tracks to the east, by the alley separating K Street and L Street to the north, and by the alley separating L Street and Imperial Avenue to the south as shown on Map B-3944, be hereby rezoned form MF-1500 to MF-3000.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this

ordinance shall be issued, except for those projects associated with a valid Southeast San Diego Development Permit, or other project where a valid application was made prior to the date of adoption of this ordinance.
