AN ORDINANCE AMENDING ORDINANCE NO. O-17326 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY TRANSFERRING THE SUM OF \$360,804 FROM THE LOCAL TRANSPORTATION FUNDS UNDER THE TRANSPORTATION DEVELOPMENT ACT OF 1971, ALL IN ACCORDANCE WITH PUBLIC UTILITIES CODE SECTIONS 992233 AND 992234, DIRECTING THE AUDITOR AND COMPTROLLER TO SET ASIDE, TRANSFER AND ALLOCATE THE \$360,804 APPROPRIATED ABOVE TO CIP NO. 58-045, "SUNSET CLIFFS BOULEVARD BRIDGE BIKEWAY."

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17326 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by transferring the sum of \$360,804 from the local transportation Funds under the Transportation Development Act of 1971, all in accordance with Public Utilities Code sections 992233 and 992234, directing the Auditor and Comptroller to set aside, transfer and allocate the \$360,804 appropriated above to CIP No. 58-045, SUNSET CLIFFS BOULEVARD BRIDGE BIKEWAY.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
