ORDINANCE NUMBER O- 17443 (NEW SERIES)

ADOPTED ON MAR 13 1990

AN ORDINANCE AMENDING ORDINANCE NO. O-17326 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17326, AS AMENDED AND ADOPTED THEREIN, TO ESTABLISH TWO SPECIAL FUNDS TO BE ENTITLED "CHILD CARE TRUST FUND" (NO. 10403), AND "CHILD CARE CONSTRUCTION TRUST FUND" (NO. 10402), SAID FUNDS TO EARN AND BE CREDITED WITH INTEREST EARNINGS IN PROPORTION TO TOTAL EARNINGS RECEIVED BY THE CITY; AND AUTHORIZING THE CITY AUDITOR AND COMPTROLLER TO ACCEPT FOR DEPOSIT AND TO DISBURSE MONIES FROM THIS FUND AS DIRECTED BY THE CITY MANAGER.

WHEREAS, the City Council supports the development of quality, affordable child care for all citizens of San Diego; and

WHEREAS, the City Council has adopted a Child Day Care Policy (Council Policy 300-12) that directs the City cooperate with agencies, organizations, and individuals in the private and public sectors who are endeavoring to meet the need for child care services in the City of San Diego; and

WHEREAS, the City will be seeking donations from both public and private sources which can be used to provide construction funding or operations funding for child care programs; and

WHEREAS, it is anticipated that unsolicited donations will also be received from businesses, individuals, and other sources throughout the community; and

WHEREAS, the City may receive funds allocated to child care from pending incentive fees or assessments; and

WHEREAS, it has been determined that a special Child Care Trust Fund and Child Care Construction Trust Fund needs to be established to deposit cash donations and other revenue, and to expend funds for their designated purposes; NOW, THEREFORE,


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17326 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17326, as amended and adopted therein, TO ESTABLISH TWO SPECIAL FUNDS TO BE ENTITLED "CHILD CARE TRUST FUND," (NO. 10403), AND "CHILD CARE CONSTRUCTION TRUST FUND," (NO. 10402), said funds to earn and be credited with interest earnings in proportion to total earnings received by the City.

Section 2. That the Auditor and Comptroller be and he is hereby directed to accept for deposit into and disburse monies from these funds as directed by the City Manager.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
