ADOPTED ON APR 16 1990

AN ORDINANCE INCORPORATING 9,600 SQUARE FEET REZONE LOCATED ON THE EAST SIDE OF 30TH STREET BETWEEN CORONADO AVENUE AND DEL SOL BOULEVARD, IN THE OTAY MESA-NESTOR COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM A-1-1 INTO CA ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0428, AND REPEALING ORDINANCE NO. 10862 (NEW SERIES), ADOPTED JUNE 29, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That 9,600 square feet, located on the east side of 30th Street between Coronado Avenue and Del Sol Boulevard, described as Portion of the Northeast quarter of the Northeast quarter of the Southeast quarter of Section 27, Township 18 South, Range 2 West, SBM, in the Otay Mesa-Nestor Community Plan area, in the City of San Diego, California, within the boundary of the district designated "CA" on Zone Map Drawing No. B-3940, filed in the office of the City Clerk as Document No. 00-17457, be, and it is hereby incorporated into CA Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0428.

Section 2. That Ordinance No. 10862 (New Series), adopted June 29, 1972, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflict herewith.
