AN ORDINANCE AMENDING ORDINANCE NO. 0-17326 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY INCREASING THE GENERAL SERVICES DEPARTMENT No 532 BUILDING DIVISION BUDGET BY \$5,000 AND INCREASING THE GENERAL FUND REVENUE ESTIMATES TO ACCOUNT FOR REIMBURSEMENT OF BUILDINGS DIVISION PERSONNEL COST FOR CONTRACT ADMINISTRATION.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-17326 (New Series), as amended, entitled "An Ordinance Adopting the Annual Budget for the Fiscal Year 1989-90 and Appropriating the Necessary Money to Operate the City for Said Fiscal Year" is hereby amended to increase the General Services Department No. 532, Building Division budget by the sum of \$5,000 and increasing the General Fund Revenue estimates to account for reimbursement of Buildings Division personnel cost for contract administration.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.

AN ORDINANCE AMENDING ORDINANCE NO. 0-17326 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY FOR SAID FISCAL YEAR" BY AMENDING THE BUDGET TO ESTABLISH CIP NO. 53-049.0, ENTITLED "PRESERVATIVE TREATMENT TO THE TORREY PINES PEDESTRIAN OVERCROSSING; DIRECTING THE AUDITOR AND COMPTROLLER TO TRANSFER AND EXPEND A SUM NOT TO EXCEED \$75,000 FROM GAS TAX FUND 302191 TO CIP NO. 53-049.0; AND AUTHORIZING THE AUDITOR AND COMPTROLLER, UPON ADVICE FROM THE ADMINISTERING DEPARTMENT TO TRANSFER EXCESS BUDGETED FUNDS, IF ANY, TO THE APPROPRIATE RESERVES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-17326, as amended, entitled "An Ordinance Adopting the Annual Budget for the Fiscal Year 1989-90, and Appropriating the Necessary Money to Operate the City for Said Fiscal Year" is hereby amended to establish CIP No. 53-049.0, entitled "PRESERVATIVE TREATMENT TO TORREY PINES PEDESTRIAN OVERCROSSING."

Section 2. That the City Auditor and Comptroller is hereby authorized to transfer \$75,000 from Gas Tax Fund No. 302191 to CIP No. 53-049.0, PRESERVATIVE TREATMENT OF TORREY PINES PEDESTRIAN OVERPASS.

Section 3. That the expenditure, not to exceed \$75,000 from Fund 302191, Account No. 9544, CIP No. 53-049.0, PRESERVATIVE TREATMENT TO THE TORREY PINES PEDESTRIAN OVERCROSSING, is hereby authorized solely and exclusively for providing funds for said project and related costs.

Section 4. That the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

Section 5. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.


