A SECOND AMENDMENT TO SECTION 1. OF ORDINANCE NO. O-16037 (NEW SERIES), ADOPTED SEPTEMBER 12, 1983, INCORPORATING A PORTION OF SECTION 33, TOWNSHIP 14 SOUTH, RANGE 3 WEST, S.B.B.M. (APPROXIMATELY 13 ACRES), LOCATED SOUTH OF CALLE CRISTOBAL, NORTH OF MIRA MESA BOULEVARD, WEST OF CAMINO SANTA FE AND EAST OF INTERSTATE 805, IN THE MIRA MESA COMMUNITY PLAN AREA AND LOCAL COASTAL PROGRAM AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R1-5000/HRO ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTIONS 101.0407 AND 101.0454.

WHEREAS, a request has been received to extend the time on Ordinance No. O-16037 (New Series), adopted September 12, 1983, which provided that the R1-5000 Zone would attach if a final subdivision map(s) was recorded on or before October 12, 1989; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1. of Ordinance No. 0-16037 (New Series), adopted September 12, 1983, is hereby amended to read as follows:

Section 1. That in the event that within three years of the effective date of this ordinance a portion of Section 33, Township 14 South, Range 3 West, S.B.B.M.

(approximately 13 acres), located south of Calle Cristobal, north of Mira Mesa Boulevard, west of Camino Santa Fe and east of Interstate 805, in the Mira Mesa Community Plan area and Local Coastal Program area, in the City of San Diego, California, within the boundary of the district designated "R1-5000/HRO" on that certain Zone Map Drawing No. B-3963, is subdivided and a final subdivision map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of San Diego Municipal Code Sections 101.0407 and 101.0454 shall attach and become applicable to said subdivided land and said subdivided land shall be incorporated into R1-5000/HRO Zone, as described by Sections 101.0407 and 101.0454, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3963, filed in the office of the City Clerk as Document No. 00-17480. Said zoning shall attach only to those areas included in the subdivision map or maps recorded as provided in this section.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after the date the California Coastal Commission unconditionally certifies this ordinance as a local coastal program amendment. If this ordinance is not certified, or is certified with suggested modifications by the

California Coastal Commission, the provisions of this ordinance shall be null and void.

Section 3. No permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefore was made prior to the date the California Coastal Commission unconditionally certified this ordinance as a local coastal program amendment.
