ORDINANCE NUMBER O- 17481 (NEW SERIES)

ADOPTED ON JUL 2 1990

AN ORDINANCE AMENDING CHAPTER X, ARTICLE 3, DIVISION 6, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 103.0602 RELATING TO THE NORTH CITY WEST PLANNED DISTRICT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

**Section 1.** That Chapter X, Article 3, Division 6, of the San Diego Municipal Code be and the same is hereby amended by amending Section 103.0602, to read as follows:

SEC. 103.0602 AREA OF APPLICABILITY

The regulations contained herein shall apply in the North City West Planned District which is within the North City West area in the City of San Diego. The area to which the provisions of this Division are applicable is shown on those certain Map Drawing Nos. C-670.4, C-671.1, C-676.4, C-679.3, C-683.2, C-694 and C-698.3, and described in the appended boundary description filed in the office of the City Clerk.

**Section 2.** That Ordinance No. O-17290 (New Series), adopted May 8, 1989, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
