
AN ORDINANCE INCORPORATING VARIOUS PROPERTIES WITHIN THE GREATER NORTH PARK AREA, WITH THE BOUNDARY OF THE AREA IDENTIFIED AS "R1-5000" ON ZONE MAP DRAWING NO. C-826.1 IN THE CITY OF SAN DIEGO, CALIFORNIA FROM MR-3000, MR-1750, MR-1500, AND MR-800B ZONES INTO R1-5000 ZONE AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0407, AND REPEALING ALL PRIOR ORDINANCES ADOPTED IN THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

That various properties within the Greater North Park Community Plan area as identified by Zone Map Drawing No. C-826.1, filed in the office of the City Clerk as Document No. OO- 17483, within the City of San Diego, California, be and it is hereby incorporated into R1-5000 Zone as such zone is described and defined by San Diego Municipal Code Section 101.0407.

Section 2. That all prior ordinances of The City of San Diego be and they are hereby repealed insofar as they conflict herewith.

Section' 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this
