BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. The City Manager be and he is hereby authorized and empowered to execute, for and on behalf of the City, the First Amendment to the joint use recreation agreement with the San Diego Unified School District as set forth in Ordinance No. O-12144 (New Series) adopted August 12, 1977, for construction, maintenance and operation of turfed playing fields at Adams Elementary School and thirteen other area schools, under the terms and conditions set forth in the First Amendment on file in the office of the City Clerk as Document No. Oo- 17503-/.

Section 2. The City Manager be and he is hereby authorized and empowered to execute, for and on behalf of the City, an agreement for construction, operation, maintenance and lease of turfed playing fields and recreation facilities at Adams

Elementary School, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. 00- 17503-2 together with any reasonable necessary modifications or amendments thereto which do not increase the agreement's scope or cost which the City Manager shall deem necessary from time to time to carry out the purposes and intent of this agreement.

Section 3. The expenditure of an amount not to exceed \$499,000.00 from CIP No. 29-710.0, Adams Avenue Park, Mid-City Park Development Fund No. 39094, is hereby authorized, solely and exclusively for the purpose of providing funds for the above agreement.

Section 4. The City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves upon advice of the administering department.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
