ADOPTED ON AUG 06 1990

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO TO DISESTABLISH THE GATEWAY CENTER EAST BUSINESS IMPROVEMENT DISTRICT.

WHEREAS, the Council of The City of San Diego, on August 10, 1987, by Ordinance No. O-16924 (New Series), created the Gateway Center East Business Improvement District pursuant to the Parking and Business Improvement Law of 1979 (California Streets and Highways Code section 36500 et seq.); and

WHEREAS, the Board of Directors of the Southeast Economic Development Corporation has requested to terminate their Agreement to administer funding for the district; and

WHEREAS, no other agency has been identified to administer the funds received from assessments in the district; NOW, THEREFORE,


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the Gateway Center East Business Improvement District be disestablished and that any fund balance be distributed according to Parking and Business Improvement Law of 1989, California Streets and Highways Code section 36500 et seq.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
