AN ORDINANCE AUTHORIZING THE EXECUTION OF AN OPERATING AGREEMENT FOR A MISDEMEANOR PRE-ARRAIGNMENT DETENTION FACILITY BETWEEN THE CITY OF SAN DIEGO AND WACKENHUT CORRECTIONS CORPORATION

BE IT ORDAINED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an Operating Agreement with WACKENHUT CORRECTIONS CORPORATION, a Florida corporation, for the design, construction and operation of a 200-bed misdemeanor pre-arraignment detention facility, under the terms and conditions set forth in that Operating Agreement on file in the office of the City Clerk as Document No. 00-17511.

BE IT FURTHER ORDAINED, that the expenditure of not to exceed \$1,549,000 from Fund 10355, Dept. 10355, Account No. 4220, for costs arising from the City's obligations under the operating agreement, is hereby authorized.

BE IT FURTHER ORDAINED, that this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
