ORDINANCE NUMBER O- 17519 (NEW SERIES)

ADOPTED ON SEP 10 1990

AN ORDINANCE AMENDING CHAPTER V, ARTICLE 9, DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 59.0104 RELATING TO ACTIVITIES PROHIBITED WITHIN SAN DIEGO JACK MURPHY STADIUM PARKING FACILITY.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter V, Article 9, Division 1, of the San Diego Municipal Code be and the same is hereby amended by amending Section 59.0104, to read as follows:

SEC. 59.0104     ACTIVITIES PROHIBITED WITHIN THE SAN DIEGO JACK MURPHY STADIUM PARKING FACILITY

(a) through (j) [No change.]

(k) Notwithstanding the provisions of paragraph (j) above, no person shall bring, or cause to be brought a beer keg for purposes other than sale or barter, or have for sale, or sell or exchange, or offer for sale or exchange, without first obtaining proof of liability insurance in an amount and form satisfactory to the City Manager and a keg permit from the Stadium Manager.


(l) The above subsections (a) - (k) shall not apply to any duly authorized employee, agent or officer of the Stadium or the City of San Diego while acting in the course and scope of his/her employment, nor shall

it apply to any duly authorized participant, performer, official, stadium security or service personnel specifically authorized to perform such an act as the Stadium Manager or the City of San Diego while acting in the scope of his/her employment or participation.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
