AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 6, DIVISION 2, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 86.2013 RELATING TO DEVELOPMENT FEES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 6, Division 2, of the San Diego Municipal Code be and the same is hereby amended by amending Section 86.2013, to read as follows:


SEC. 86.2013 Permit Fees

(a) The fees for residential permit parking shall be set by the Council based upon the recommendation of the City Manager. The City Manager shall from time to time recommend such fees to the Council that reflect an amount to equal but not to exceed the cost of the administration of the program.

(b) A copy of the fee schedule shall be filed in the rate book of fees on file in the office of the City Clerk.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


