reconsider the ordinance, and if the Council refuses to grant the
petition to repeal said ordinance or fails to reconsider the

ordinance within ten (10) days after presentation by the City Clerk, then the Council shall forthwith adopt a resolution of intention to submit the matter to the people at a special election or any other election at which all the voters of the City are entitled to vote, to be held within eleven (11) months from the date the Referendary Petition is presented to the Council; and

WHEREAS, the Council on ANG 1990 accepted the above referenced petition, reconsidered Ordinance No. 0-17481 (New Series), and indicated its intention to repeal the same; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That upon Council's reconsideration of Ordinance No. O-17481 (New Series), the above-referenced petition is hereby granted and Ordinance No. O-17481 (New Series) is hereby repealed.

Section 2. That this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
