AN ORDINANCE AMENDING ORDINANCE NO. O-17504 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17504-1, AS AMENDED AND ADOPTED THEREIN, BY EXEMPTING ONE (1.00) EQUAL OPPORTUNITY CONTRACTING MANAGER POSITION FROM THE CLASSIFIED SERVICE; CAUSING THE PERSONNEL AUTHORIZATION SCHEDULE OF THE PURCHASING DEPARTMENT (057) TO REFLECT THE EQUAL OPPORTUNITY CONTRACTING MANAGER POSITION AS UNCLASSIFIED; AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, the City Manager requested the position of Equal Opportunity Contracting Manager in the Purchasing Department be exempted from the classified service; and

WHEREAS, this position has significant management level responsibilities; and

WHEREAS, section 117(a)17 of the Charter provides that
"managerial employees having significant responsibilities for
formulating or administering departmental policies and programs"
may be exempted from the classified service by ordinance upon
first having been reviewed and commented upon by the Civil
Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on June 7, 1990 and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, this action will amend the appropriation ordinance to exempt the Equal Opportunity Contracting Manager position from the classified service; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That pursuant to section 117(a)17 of the City
Charter, after having been reviewed and commented upon favorably
by the Civil Service Commission on June 7, 1990, the Equal
Opportunity Contracting Manager position in the Purchasing
Department (057), be and it is hereby exempted from the
classified service and declared to be in the unclassified service
of The City of San Diego.

Section 2. That Ordinance No. 17504 (Ne Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATE THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-17504-1, as amended and adopted therein, by amending the personnel authorization of the Purchasing Department (057), to reflect the exemption of the Equal Opportunity Contracting Manager from the classified service and placement in the unclassified service.

Section 3. As a schedule of compensation for the above unclassified position recited in sections 1 and 2 hereof, funds appropriated and available therefor in the Purchasing Department, the salary rate set forth in Salary Rates 7.3, 7.4, 7.5 and 7.6 of the Table of Classifications and Standard Salary Rates under Managerial Category B, contained in Exhibit C to Ordinance No. O-17468 (New Series), be and the same is hereby adopted.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
