BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-17326 (New Series), as amended, entitled "An Ordinance Adopting the Annual Budget for the Fiscal Year 1989-1990 and Appropriating the Necessary Money to Operate the City for Said Fiscal Year" is hereby modified to add CIP No. 37-232.0, EXPANSION OF THE EXISTING ENERGY MANAGEMENT CONTROL SYSTEM.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
