AN ORDINANCE INCORPORATING A PORTION OF THE NW 1/4 OF THE NW 1/4 OF THE NW 1/4 OF SECTION 35, TOWNSHIP 18 SOUTH, RANGE 2 WEST, SAN BERNARDINO MERIDIAN (A 0.96 ACRE SITE) IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM A-1-5 ZONE INTO CN ZONE, IN THE OTAY MESA-NESTOR COMMUNITY PLAN AREA, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0426, AND REPEALING ORDINANCE NO. 10862 (NEW SERIES), ADOPTED JUNE 29, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of the NW 1/4 of the NW 1/4 of the NW 1/4 of Section 35, Township 18 South, Range 2 West, San

Bernardino Meridian (a 0.96 acre site), located on the south side of Iris Avenue between Howard Avenue on the west and the San

Diego and Arizona Eastern Railroad track on the east, in the Otay

Mesa-Nestor Community Plan area, in the City of San Diego,

California, within the boundary of the district designated "CN"

on Zone Map Drawing No. B-3949, filed in the office of the City

Clerk as Document No. 17530, be, and it is hereby

incorporated into CN Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0426.

Section 2. That Ordinance No. 10862 (New Series), adopted June 29, 1972, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
