AN ORDINANCE AMENDING CHAPTER V, ARTICLE 5, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTIONS 55.0102.0303 AND 55.0311.0412; AMENDING CHAPTER IX, ARTICLE 2, BY AMENDING SECTION 92.0105; AMENDING CHAPTER IX, ARTICLE 6, BY AMENDING SECTION 96.0402; AMENDING CHAPTER X, ARTICLE 1, BY AMENDING SECTIONS 101.0260, 101.0702, AND 101.1901; AND BY AMENDING CHAPTER X, ARTICLE 3, BY AMENDING SECTION 103.0403, ALL RELATING TO AND NECESSITATED BY RENUMBERING OF CHAPTER IX OF THE MUNICIPAL CODE BY ORDINANCE NO. 0-17390 (NEW SERIES).

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1: That Chapter V, Article 5, Division 1, Section 55.0102.0303, of the San Diego Municipal Code be and the same is hereby amended by renumbering Section 91.02.0204 appearing within the text of that section to read Section 91.0204.

Section 2: That Chapter V, Article 5, Division 3, Section 55.0311.0412 of the San Diego Municipal Code is hereby amended by renumbering Section 91.02.0203 appearing within the text of that section to read Section 91.0203.

Section 3: That Chapter IX, Article 2, Division 1, Section 92.0105, of the San Diego Municipal Code is hereby amended by renumbering Section 91.02.0204 appearing in the text of that section to read Section 91.0204.

Section 4: That Chapter IX, Article 6, Division 4, Section 96.0402, is hereby amended by renumbering Section 91.02.0303 appearing in the text of that section to read Section 91.0303.

Section 5: That Chapter X, Article 1, Division 2, Section 101.0260, is hereby amended by renumbering Section 91.01 appearing in the text of that section to read Section 91.0101.

Section 6: That Chapter X, Article 1, Division 7, Section 101.0702, is hereby amended by renumbering Section 91.02.0104 appearing within the text of that section to read 91.0104.

Section 7: That Chapter X, Article 1, Division 19, Section 101.1901 is hereby amended by renumbering Section 91.01 appearing within the text of that section to read Section 91.0101.

Section 8: That Chapter X, Article 3, Division 4, Section 103.0403 is hereby amended by renumbering Section 91.02.0303 appearing in the text of that section to read Section 91.0303.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


