ORDINANCE NUMBER O- 0-17539 (NEW SERIES)

ADOPTED ON OCT 15 1990

AN ORDINANCE CHANGING AND ESTABLISHING THE BOUNDARY LINES OF THE DISTRICTS WITHIN THE CITY OF SAN DIEGO FOR THE PURPOSE OF ELECTING MEMBERS OF THE CITY COUNCIL, AND REPEALING ORDINANCE NO. 17517 (NEW SERIES), ADOPTED AUGUST 27, 1990.

WHEREAS, The City of San Diego was sued in a class action entitled Mirna Perez, et al. v. City of San Diego, et al., Case No. 88-0103-R(M) in the United States District for the Southern District of California wherein the plaintiffs alleged, among other things, violations of the 1965 Voting Rights Act, violations of the One Person One Vote Doctrine and Estoppel; and

WHEREAS, in September of 1989, a settlement agreement was signed by the parties and filed with the court in connection with Case No. 88-0103-R(M); and

WHEREAS, pursuant to said agreement, the City Council proceeded to redistrict the City by duly adopting Ordinance No. O-17517 (New Series) on August 27, 1990 in accordance with Map 20 and the census tract tables attached thereto; and

WHEREAS, a dispute between the parties arose as to whether the settlement agreement executed in September 1989 had been complied with; and

WHEREAS, the U.S. District Court, having jurisdiction in the case, ordered the parties to continue negotiations in order to resolve the dispute; and

WHEREAS, a revised settlement agreement incorporating Map 23A was agreed to by the parties in September 1990 and filed with the court, thus terminating the litigation subject to the court's approval; and

WHEREAS, the U.S. District Court has ordered the agreed upon redistricting to proceed in accordance with Map 23A, thus requiring the repeal of Ordinance No. O-17517; and

WHEREAS, it is now appropriate and necessary to amend the boundaries of The City of San Diego in accordance with Map 23A and the census tract tables attached thereto; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That boundary lines of the eight districts of The City of San Diego, for the purpose of electing members of the Council, are hereby established, as more particularly shown and delineated on a map showing boundary lines of the districts and census tract lists associated therewith on file in the office of the City Clerk as Document No. OO- 17539 which is, by this reference, fully incorporated in and made a part of this ordinance.

Section 2. The offices of the Council members elected from even-numbered councilmanic districts shall be regularly up for election every four years commencing in 1991. The offices of Council members elected from odd-numbered councilmanic districts shall be regularly up for election every four years commencing in 1993.

Section 3. Ordinance No. 17517 (New Series), adopted August 27, 1990, is hereby repealed.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
