AN ORDINANCE AMENDING CHAPTER III, ARTICLE 3, DIVISION 39, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 33.3917 RELATING TO AN INCREASE IN THE HOURLY CHARGE TO CARDROOM PLAYERS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter III, Article 3, Division 39, of the San Diego Municipal Code be and the same is hereby amended by amending Section 33.3917, to read as follows:

**SECTION 33.3917 CHARGES**

No charge in excess of four dollars (\$4.00) per hour shall be collected from any player for the privilege of participating in any game.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


