AN ORDINANCE AMENDING CHAPTER IX, ARTICLE 8,  
DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE  
BY AMENDING SECTION 98.0107 RELATING TO  
HOUSING PERMITS REQUIRED.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter IX, Article 8, Division 1, of the San Diego Municipal Code be and the same is hereby amended by amending Section 98.0107, to read as follows:

§ 98.0107 Housing Permits Required


- a) No change to this subsection.
- b) Housing Department regulated businesses and activities are defined as but not limited to the operation of buildings occupied or intended to be used for sleeping purposes by six (6) or more persons, any building or portion thereof which contains two (2) or more dwelling units, hotels as defined in Chapter 4 of the Uniform Building Code as adopted herein, or any single family residential unit for which a business tax is required to be paid under section 31.0305 of this Code.
- c) No change to this subsection.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

This ordinance amends San Diego Municipal Code section 98.0107 to revise the categories of regulated housing for which a housing permit shall be required. The revision adds two new categories of regulated housing: a) buildings which contain two or more dwelling units; and (b) single family residential units when rented for which a business tax is required to be paid under the provisions of San Diego Municipal Code section 31.0305.
