AN ORDINANCE AMENDING ORDINANCE NO. 0-17504-1 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-17504-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF THE BUILDING INSPECTION DEPARTMENT (1300), ENTERPRISE FUND 41300, BY ADDING TWO (2.00) BUILDING INSPECTOR II POSITIONS, ONE (1.00) WORD PROCESSING OPERATOR, AND TWO (2.00) CLERICAL ASSISTANT II POSITIONS; AUTHORIZING THE AUDITOR AND COMPTROLLER TO INCREASE THE BUILDING INSPECTION ENTERPRISE FUND 41300 BY \$277,995 TO ACCOMMODATE COST OF ADDITIONAL POSITIONS. SAID FUNDS TO COME FROM RECOVERED FEES IN THE FULL COST RECOVERY HOUSING INSPECTION PROGRAM AND FULL TIME DRUG ABATEMENT PROGRAM.

WHEREAS, on September 19, 1990, the Public Services and Safety (PS&S) Committee approved the City Manager's recommendation to support implementation of a full time Drug Abatement Program and a full cost recovery Housing Inspection Program; and

WHEREAS, the proposal included the addition of and funding for two (2.00) Building Inspectors II, one (1.00) Word Processing Operator, and two (2.00) Clerical Assistant II positions in the Housing Inspection Program; and

WHEREAS, the PS&S Committee forwarded the matter to the full Council with a recommendation to approve the City Manager's proposal, as set forth in City Manager Report No. 90-448 to the Mayor and Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17504 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17504-1, as amended and adopted therein, by amending the personnel authorization of the Building Inspection Department (1300), Enterprise Fund 41300, by adding two (2.00) Building Inspector II positions, one (1.00) Word Processing Operator position, and two (2.00) Clerical Assistant II positions.

Section 2. That the Auditor and Comptroller be and he is hereby authorized to increase the Building Inspection Department and Building Inspection Enterprise Fund 41300 by \$277,995 to defray the costs associated with the positions added in section 1 above, said funds to come from recovered fees in the full cost recovery Housing Inspection Program and full time Drug Abatement Program.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant

to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
