AN EMERGENCY ORDINANCE LIMITING ISSUANCE OF BUILDING PERMITS AND COMMENCEMENT OF CONSTRUCTION IN A PORTION OF CENTRE CITY SAN DIEGO FOR A PERIOD OF ONE YEAR OR UNTIL THE INTERIM CENTRE CITY SAN DIEGO DESIGN AND DEVELOPMENT ORDINANCE IS CERTIFIED BY THE CALIFORNIA COASTAL COMMISSION.

WHEREAS, The City of San Diego, under the police power delegated to it by the Constitution of the State of California, has the authority to react when the public health, safety and general welfare of its citizens are jeopardized; and

WHEREAS, the Planning Commission and Council of The City of San Diego will consider extending the Interim Centre City San Diego Development and Design Ordinance into those areas of the Centre City Community Plan area which fall under the jurisdiction of the California Coastal Commission; and

WHEREAS, the California Coastal Commission will consider an amendment to the Local Coastal Program (LCP) to include the Interim Development and Design Ordinance in December 1990 or thereafter; and

WHEREAS, The City of San Diego cannot issue a Coastal

Development Permit under the regulations of the Interim

Development and Design Ordinance until the document is certified

by the California Coastal Commission; and

WHEREAS, San Diego Municipal Code section 101.0203.1 empowers the Council to adopt as an emergency measure in the

interest of public safety, health and welfare, a temporary interim zoning ordinance pending the study and recommendation of zoning restrictions on an area of land within the City; NOW THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

SECTION 1. Within the area known as Harborview in the Centre City San Diego Community Plan area and for that portion in the Coastal Zone bounded by Laurel Street on the north, California Street on the east, Ash Street on the south and Pacific Highway on the west as shown on Map Drawing No. C-833 a copy of which is on file in the office of the City Clerk as Document No. 17547, no building permits shall be issued for construction of any structure over 85 feet in height for the blocks bounded by Grape, California, and Ash Streets and Pacific Highway; heights in remaining blocks bounded by Laurel, California, and Grape Streets and Pacific Highway to be determined by the Airport Approach Overlay Zone, the Federal Aviation Administration and the San Diego Unified Port District. The floor area ratio (FAR) in the Coastal Zone shall be as follows:

- 1. 5.5 for the block bounded by Laurel, California, and Grape Streets and Pacific Highway.
- 2. 4.0 for the blocks bounded by Grape, California, and Ash streets and Pacific Highway.

SECTION 2. All projects will be reviewed by the Council.

SECTION 3. Any requested variances to Section 1 shall be processed as a ten-day noticed public hearing before the Council. This action will require environmental review.

SECTION 4. The provisions of this ordinance shall remain in force and effect for a period of one year from the date of adoption of this ordinance or until the Interim Centre City San Diego Development and Design Ordinance is certified by the California Coastal Commission.

SECTION 5. For the reasons expressed in the preamble hereto, this ordinance shall take effect immediately upon its passage as an emergency measure necessary to protect and preserve the public health, safety and general welfare and except as provided by this ordinance, no building permits for development inconsistent with the provisions of this ordinance shall be issued.
