ADOPTED ON NOV 13 1990

AN ORDINANCE AMENDING ORDINANCE NO. O-17504 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17504-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF THE WATER UTILITIES DEPARTMENT (41500) ENGINEERING DIVISION TO DELETE ONE (1.00) SENIOR DRAFTING AIDE POSITION AND ADD IN LIEU THEREOF ONE (1.00) ASSISTANT DEPUTY DIRECTOR POSITION; EXEMPTING SAID ASSISTANT DEPUTY DIRECTOR FROM THE CLASSIFIED SERVICE; AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, the Engineering Division of the Water Utilities Department is responsible for Capital Improvements Program planning, design of replacement and expansion of the water and wastewater systems, contract construction of water and sewer facilities, and maintaining maps and records; and

WHEREAS, this division consists of 107 positions, responsible for administering a \$125 million annual Capital Improvements Program with 120 projects and, at present the work effort is overseen solely by a Deputy Director; and

WHEREAS, in order to enhance the ability of this position to develop policy, manage resources and carry out long range planning and forecasting, an Assistant Deputy Director has been added to the division; and

WHEREAS, the Assistant Deputy Director will assist the Deputy Director in planning, directing and coordinating departmental policies to ensure timely and appropriate implementation of all engineering programmatic responsibilities; and

WHEREAS, this position is in lieu of a Senior Drafting Aide which is presently authorized, thereby keeping overall authorized personnel unchanged; and

WHEREAS, the Assistant Deputy Director will have significant management level responsibilities which fall within the managerial definition contained in Charter section 117(a)17 and which justifies exemption from the classified service; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the classified service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on September 6, 1990 and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, this action will amend the appropriation ordinance to substitute the new position in the budget and exempt it from the classified service and establish a salary rate; NOW,

THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17504 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17504-1, as amended and adopted therein, by amending the personnel authorization of the Water Utilities Department (41500), Engineering Division, to delete one (1.00) Senior Drafting Aide position and adding in lieu thereof one (1.00) Assistant Deputy Director position.

Section 2. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on September 6, 1990, the new Assistant Deputy Director position in the Engineering Division of the Water Utilities Department (41500), be and it is hereby exempted from the classified service and declared to be in the unclassified service of The City of San Diego.

Section 3. As a schedule of compensation for the above unclassified position recited in sections 1 and 2 hereof, the salary rate set forth in Salary Rates 7.3, 7.4, 7.5 and 7.6 of the Table of Classifications and Standard Salary Rates under Managerial Category B, contained in Exhibit C to Ordinance No. O-17468 (New Series), be and the same is hereby adopted.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant

to the authority contained in Sections 16, 17 and 71 of the
Charter of The City of San Diego.


