AN ORDINANCE AMENDING ORDINANCE NO. O-17468 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1990-91" BY AMENDING EXHIBIT B THERETO TO CREATE AND ADD A NEW CLASS ENTITLED "POLICE LEAD DISPATCHER" IN THE COMMUNICATIONS OCCUPATION GROUP; AMENDING EXHIBIT A-1 OF SAID ORDINANCE TO PROVIDE A NEW SALARY RATE 66.1 FOR SAID POSITION IN THE CLASSIFIED SERVICE, AS SET FORTH IN ATTACHMENT A HERETO; AMENDING RESOLUTION NO. R-275865 TO PLACE THE NEWLY CREATED CLASS IN THE TECHNICAL BARGAINING UNIT; AND AMENDING RESOLUTION NO. R-275864 TO APPROVE AND DECLARE THE ABOVE NEWLY CREATED CLASS AS ELIGIBLE FOR PREMIUM RATE OVERTIME BY PLACING IT IN GROUP A OF SAID OVERTIME ELIGIBILITY RESOLUTION NO. R-275864.

WHEREAS, the Police Department has requested the creation of a new lead dispatcher classification in the Police Communications Center to staff the central dispatch console units in the Phone Room and the Radio Room; and

WHEREAS, as proposed, this new class will monitor and coordinate the dispatch functions in the Police Communications Center which is responsible for responding to City-wide telephone requests for police assistance; and

WHEREAS, it is recommended that a new class of Police Lead Dispatcher be created at a salary of \$2,312 - \$2,786/month to encompass these duties; and

WHEREAS, it is also recommended that the Police Lead Dispatcher classification be eligible for premium rate overtime

under the same conditions as other classes designated as nonexempt from the overtime provisions of the Fair Labor Standards Act; and

WHEREAS, it is recommended that this new classification be placed in the Technical Bargaining Unit; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17468 (New Series), as amended, entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1990-91" be and the same is hereby amended by amending Exhibit B thereto to create and add a new class entitled "POLICE LEAD DISPATCHER" in the Communication's Occupation Group.


Section 2. That Exhibit A-1 of said Ordinance No. O-17468 (New Series) be and the same is hereby amended to provide a new salary rate 66.1 for said position in the classified service, as set forth in attachment A hereto.

Section 3. That Resolution No. R-275865 be and it is hereby amended to place the newly created position in section 1 above in the Technical Bargaining Unit.

Section 4. That Resolution No. R-275864 be and it is hereby amended to approve and declare the above newly created position as eligible for premium rate overtime by placing it in Group A of said overtime eligibility Resolution No. R-275864.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
