AN ORDINANCE AMENDING ORDINANCE NO. O-17468 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1990-91" BY AMENDING EXHIBIT B THERETO TO CREATE AND ADD A NEW CLASS ENTITLED "WORK CONTROL MANAGER" IN THE ENGINEERING OCCUPATION GROUP; AMENDING EXHIBIT A-1 OF SAID ORDINANCE TO PROVIDE A NEW SALARY RATE 99.4 FOR SAID POSITION IN THE CLASSIFIED SERVICE, AS SET FORTH IN ATTACHMENT A HERETO; AMENDING RESOLUTION NO. R-275865 TO PLACE THE NEWLY CREATED CLASS IN THE SUPERVISORY REPRESENTATION UNIT; AND AMENDING RESOLUTION NO. R-275864 TO APPROVE AND DECLARE THE ABOVE NEWLY CREATED CLASS AS ELIGIBLE FOR REGULAR RATE OVERTIME BY PLACING IT IN GROUP C OF SAID OVERTIME ELIGIBILITY RESOLUTION NO. R-275864.

WHEREAS, the General Services Department has requested a new classification of Work Control Manager to supervise and manage the functions of the Work Control and Construction Project Unit and the Engineering Support Unit; and

WHEREAS, this request was initiated as the result of a reorganization within the Buildings Division; and

WHEREAS, as proposed, this new class will supervise the Work Control Center which is responsible for coordinating the scheduling of contract work and City work crews for the division's major repair; maintenance and improvement projects; estimating and processing work requests, administering the division's construction projects; and providing engineering and design support for the division; and

WHEREAS, there is currently no existing classification which encompasses the duties described above, therefore, it is recommended that a new class of Work Control Manager be created at a salary of approximately \$3,406 - \$4,115/month; and

WHEREAS, it is also recommended that this class be eligible for regular rate overtime under the same conditions as other comparable supervisory classes in the City which are designated as exempt from the overtime provisions of the Fair Labor Standards Act but eligible for regular rate overtime in accordance with City policy; and

WHEREAS, it is recommended that this new classification be placed in the Supervisory Bargaining Unit; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17468 (New Series), as amended, entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1990-91" be and the same is hereby amended by amending Exhibit B thereto to create and add a new class entitled "WORK CONTROL MANAGER" in the Engineering Occupation Group.

Section 2. That Exhibit A-1 of said Ordinance No. O-17468 (New Series) be and the same is hereby amended to provide a new salary rate 99.4 for said position in the classified service, as set forth in attachment A hereto.

Section 3. That Resolution No. R-275865 be and it is hereby amended to place the newly created position in section 1 above in the Supervisory Representation Unit.

Section 4. That Resolution No. R-275864 be and it is hereby amended to approve and declare the above newly created position as eligible for regular rate overtime by placing it in Group C of said overtime eligibility Resolution No. R-275864.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

R-275884 TO APPROVE AND DECLARE THE ABOVE NEWLY CREATED CLASS AS ELIGIBLE FOR REGULAR RATE OVERTIME BY PLACING IT IN GROUP C OF SAID OVERTIME ELIGIBILITY RESOLUTION NO. R-275884.

The ordinance also places the newly created class in the Supervisory Representation Unit, and establishes a salary rate and overtime eligibility for said new classification.
