BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17504 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17504-1, as amended and adopted therein, by amending the personnel authorization of the Risk Management Department (084) by adding one (1.00) Safety Representative II position for the purpose of administering the state mandated safety programs.

Section 2. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$143,008 to Risk Management (084) Revolving Fund (50061) from the following sources: \$128,600 - Unallocated Reserve (605), \$9,173 - Waste Management Enterprise Fund (41200), \$2,680 - Airports Enterprise Fund (41100), and \$2,555 - Building Inspection Enterprise Fund (41300), to be used for the sole and exclusive purpose of defraying personnel and nonpersonnel expenses in connection with administration of state mandated safety programs.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
