BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17504 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17504-1, as amended and adopted therein, by authorizing the Auditor and Comptroller to increase the General Fund (100) Appropriation and Non-departmental Expenditures (Department 601) by \$1,675,607, due to availability of heretofore unappropriated General Fund Fiscal Year 1990 Closing Undesignated Fund balance.

Section 2. That the Auditor and Comptroller is hereby authorized to allocate said funds for County of San Diego Property Tax administration and collection charges.

Section 3. That the Auditor and Comptroller be and he is hereby authorized to expend the above amount solely and exclusively for said purposes.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
