AN ORDINANCE AMENDING ORDINANCE NO. 0-17504 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-17504-1, AS AMENDED AND ADOPTED THEREIN, BY AUTHORIZING THE AUDITOR AND COMPTROLLER TO INCREASE THE GENERAL FUND (100) BY \$300,000, DUE TO THE AVAILABILITY OF HERETOFORE UNAPPROPRIATED TRANSFER OF FUNDS FROM THE ARTS FESTIVAL CORPORATION AND ALLOCATING SAID \$300,000 TO THE ALLOCATED RESERVE (901); AUTHORIZING THE AUDITOR AND COMPTROLLER TO APPROPRIATE AND ALLOCATE SAID \$300,000 TO OFFSET REDUCTIONS IN TRANSIENT TRANSPORTATION REVENUES IN THE AMOUNT OF \$235,000 AND \$65,000 FOR THE SCHOOL SAFETY PATROL PROGRAM (SUMMER CAMP).

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17504 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17504-1, as amended and adopted therein, by authorizing the Auditor and Comptroller to increase the General Fund (100) by \$300,000, due to the availability of heretofore unappropriated transfer of funds from the Arts Festival Corporation and allocating said \$300,000 to the Allocated Reserve (901).

Section 2. That the Auditor and Comptroller be and he is hereby authorized to appropriate and allocate \$235,000 to offset reductions in transient transportation revenues.

Section 3. That the Auditor and Comptroller be and he is hereby authorized to allocate \$65,000 for the School Safety Patrol Program (Summer Camp) in the Allocated Reserve (901).

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
