AN ORDINANCE CHANGING A SETBACK LINE ESTABLISHED PURSUANT TO CITY OF SAN DIEGO TRACT NO. 3787 ALONG MORENA BOULEVARD FROM 25 FEET TO 10 FEET FOR THE PERIOD ENDING JUNE 30, 1997

WHEREAS, San Diego Municipal Code Section 101.0604 provides a procedure to change a setback line established pursuant to a subdivision tract map. The City of San Diego Subdivision Tract Map No. 3787 established a setback along Morena Boulevard of 25 feet in order to ensure adequate right-of-way for Morena Boulevard and a proposed drainage facility; and

WHEREAS, the construction of the drainage facility and Morena Boulevard have eliminated the need for the 25-foot setback established by City of San Diego Subdivision Tract Map No. 3787; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. The 25-foot setback established by City of San Diego Subdivision Tract Map No. 3787 is hereby changed for the period ending June 30, 1997, and upon the shifting of all storage bins at least 16 feet from the main building to provide for a fire lane, and upon installation of landscaping satisfactory to the Planning Director in the subject area, to 10 feet along Morena Boulevard for 350 feet adjacent to the Rose Canyon Warehouse (4627 Morena Boulevard) pursuant to San Diego Municipal

Code Sections 101.0604 and 101.0607.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage or at such later date as the shifting of the storage bins and the landscaping are approved by the Planning Director.
