BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$15,000 from CIP 61-001.0 ANNUAL ALLOCATION - SIGNAL INSTALLATIONS TO ACCOMMODATE SUDDEN TRAFFIC CHANGES, Capital Outlay Fund 30245 into CIP 62-292.0, TRAFFIC SIGNALS - DIF FUNDED, Fund 30245.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to amend the 1989-90 Annual Budget (0-17326) and transfer \$5,000 from DIF Fund 79527 to CIF 62-292.0, TRAFFIC SIGNALS - DIF FUNDED, for the CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT CARMEL VALLEY ROAD AND DEL MAR SCENIC PARKWAY.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$110,100 (\$15,000 from Capital Outlay Fund 30245 and \$95,100 from DIF Fund 79527) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
