

RESOLUTION NUMBER R- 274909

ADOPTED ON JAN 08 1990

BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for IMPROVEMENT OF FARNHAM STREET, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on JAN 08 1990, and bearing official Document No. W.O. 119315, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for IMPROVEMENT OF FARNHAM STREET.


BE IT FURTHER RESOLVED, that the City Manager is hereby authorized, if circumstances warrant, to finance or refinance this project with tax exempt securities.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$90,000 from Capital Outlay Other Revenue Fund 302453, CIP No. 37-028.0 ANNUAL ALLOCATION UNDERGROUNDING OF CITY UTILITIES, to CIP No. 52-350.0, FARNHAM AVENUE - OVERLAND AVENUE TO 800 FEET EAST OF OVERLAND.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to reimburse CIP No. 37-028.0, ANNUAL ALLOCATION UNDERGROUNDING OF CITY UTILITIES in an amount not to exceed \$90,000 from abutting property owner payments received for street improvements constructed adjacent to their property.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$159,132 from CIP No. 52-350.0, ANNUAL ALLOCATION UNDERGROUNDING OF CITY UTILITIES (\$90,000 from Fund 302453 and \$69,132 from Fund 36022) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
