RESOLUTION NUMBER R- 274927

ADOPTED ON JAN 08 1990

WHEREAS, by Resolution No. R-273762, adopted on June 19, 1989, the Council of The City of San Diego provided that the vacation of Carmel View Road east and west of Caminito del Mar Shores, in connection with Carmel View Center (TM 87-0228), would occur only after the following condition has been met: approval of the final map for Carmel Valley Center (TM 87-0228); and

WHEREAS, as the abutting property owners have requested a change to the condition established by Resolution No. R-273762; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Paragraph 8 of Resolution No. R-273762, adopted June 19, 1989, which is on file in the office of the City Clerk, be, and the same is hereby ordered, amended as follows: "WHEREAS, it is necessary and desirable that the vacation be conditioned upon completion of certain public improvements."


2. That Item 1 of Resolution No. R-273762, adopted June 19, 1989, which is on file in the office of the City Clerk, be, and the same is hereby, amended as follows: "That Carmel View Road east and west of Caminito del Mar Shores, in connection with Carmel Valley Center (TM 87-0228), as more particularly shown on revised Drawing No. 24346-D, on file in the office of the City Clerk as Drawing No. RR- 274927-1, which is by reference

incorporated herein and made a part hereof, be, and the same is hereby ordered vacated."

3. That Item 6 of Resolution No. R-273762, adopted June 19, 1989, which is on file in the office of the City Clerk, be, and the same is hereby, amended as follows: "That this Resolution shall not become effective unless and until the public improvements for the realignment of Carmel View Road and construction of Carmel Center Road have been completed and open to public use. In the event that the public improvements are not completed by November 12, 1993, this Resolution shall become void and of no further force or effect.

4. That the City Engineer shall advise the City Clerk of compliance and completion of the above-mentioned condition and that the City Clerk shall then cause a certified copy of this Resolution, attested by him under seal, to be recorded in the office of the County Recorder.
