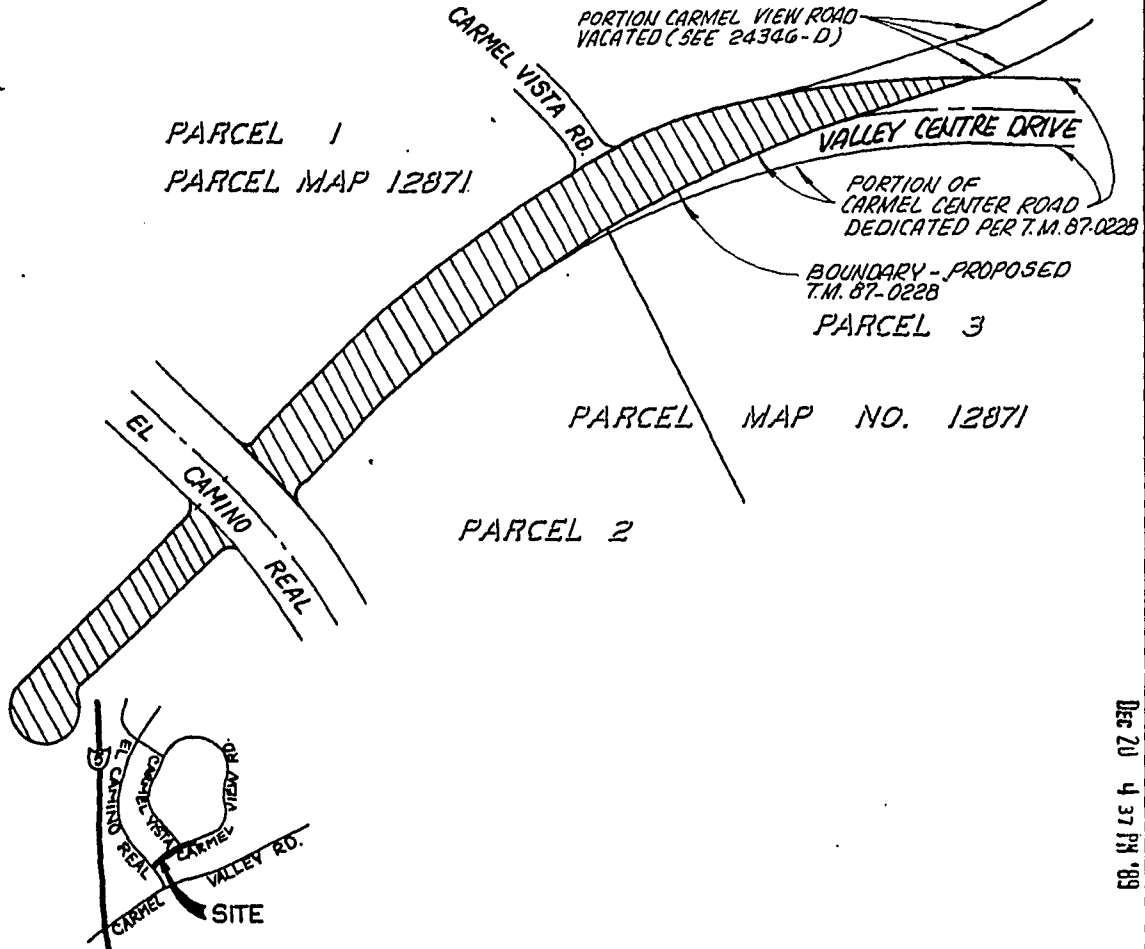

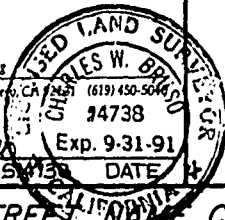
**VICINITY MAP**
