ADOPTED ON JANUARY 8, 1990

BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure of an amount not to exceed \$10,146 from Gas Tax Fund 32191, C.I.P. 37-028, Annual Allocation, Undergrounding of City Utilities as payment to San Diego Gas and Electric Company, is hereby authorized, solely and exclusively, for the purchase of one (1) new street light to replace an existing pole mounted street light in the India Street/Cedar Street Underground Utility District.

City Council approval of this item is contingent upon a determination of exemption from the provisions of SB 255 by the Airport Land Use Commission.
