

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, Change Order No. 2 to Contract 3, Phase I, with D&M Grading Company, Inc, for the West Miramar Solid Waste Disposal Facility, under the terms and conditions set forth in the Change Order No. 2 on file in the office of the City Clerk as Document No. RR- 274954, with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the additional expenditure of an amount not to exceed \$55,820.16 from CIP No. 37-055.4, Capital Outlay Other Fund 302453, is hereby authorized, solely and exclusively for the purpose of providing funds for the above change order.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves upon advice of the administering department.
