WHEREAS, Chief Auto Parts, Inc., has taken the first steps to close the gap in California's environmental laws by agreeing to accept used motor oil at its four San Diego County stores; and

WHEREAS, this action by Chief Auto Parts, Inc., is an uncommon public service for an automobile parts store chain; and

WHEREAS, Chief Auto Parts, Inc., is the first automobile parts establishment to adopt a corporate commitment of alerting its customers to environmentally preferable products and the importance of biodegradability and recyclability in its product line; and

WHEREAS, used motor oil, because of its large volume, is recognized as a major hazard to the environment recognizing that at least 50 million gallons are illegally dumped each year in California; and

WHEREAS, at least 1.5 million gallons of used motor oil is estimated to be illegally dumped in San Diego County, discarded with rubbish and polluting our landfills; and

WHEREAS, Chief Auto Parts, Inc., has provided hope for reducing landfill pollution by providing a convenient option for individuals to dispose of used motor oil; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby commends and congratulates Chief Auto Parts, Inc., for its

commitment to enhancing the environment of the San Diego area through its corporate programs of accepting used motor oil at its area stores.

BE IT FURTHER RESOLVED, that in recognition of its commitment to environmental wellbeing, this Council hereby proclaims and declares January 1990 to be "CHIEF AUTO PARTS, INC. MONTH" in San Diego.
