WHEREAS, the Civic Theater will celebrate its Silver Anniversary in 1990 marking twenty-five years as San Diego's premier performance facility for the performing arts; and

WHEREAS, prior to its construction, the Civic Theater had been dreamt of for decades by a group of dedicated citizens who envisioned a fitting sanctuary for performing act as an integral part of our city; and

WHEREAS, City government and scores of companies and prominent individuals committed to a revitalized center city and the arts joined forces to provide the San Diegans and visitors alike with a performance theater which in the past and present has served as home to the San Diego Symphony, San Diego Opera, the Starlight Opera, the Broadway Theater League and the International Artists Series; and

WHEREAS, January 12 through 16, 1965 marked the official opening of the long awaited Civic Theatre, a new center for San Diego's performing arts community, a community dedicated to presenting San Diego audiences with theatrical and musical productions of the highest quality; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby proclaims January 15 through 21, 1990 to be "CIVIC THEATER AWARENESS WEEK" in San Diego and commends the many individuals

and organizations who have played key roles in the establishment
and ongoing success of San Diego's Civic Theater.
