BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to delete the funds for the expert witness services from Second Amendment to the JAMES M. MONTGOMERY Agreement in the amount of \$76,987 and to allocate the funds for these services to

cover the costs incurred by the City Attorney's Office in support of Clean Water Program and to be paid by the Risk Management Department.
