RESOLUTION NUMBER R-274993

ADOPTED ON JANUARY 16, 1990

WHEREAS, as part of the settlement in federal court of the voting rights litigation entitled Perez, et al. v. City of San Diego, et al., the City of San Diego agreed to create an ad hoc Redistricting Advisory Board pursuant to section 43(b) of the City Charter; and

WHEREAS, said settlement specified that the Board should consist of a racial, geographical and ethnic mixture as called for in section 42 of the Charter; and

WHEREAS, Council Policy 000-13 requires appointees to any City agency to be residents of The City of San Diego, provided that a non-city resident may be appointed when unique qualifications exist and the Council makes a conscious exception and waives the policy; and

WHEREAS, said Board shall be advisory to the City Council and City Manager on the boundaries to be established for redistricting in the City of San Diego; and

WHEREAS, the Board shall consist of seventeen (17) members, one (1) each to be appointed by each Council District and nine (9) to be appointed by the Mayor; and

WHEREAS, said Board shall function solely and exclusively as advisory to the Council and Manager in the matter of providing such redistricting input and support; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that, pursuant to section 43(b) of the City Charter, there is hereby established a Redistricting Advisory Board to consist of seventeen (17) members appointed as follows: One (1) from each Council District and nine (9) by the Mayor from the City-at-large.

BE IT FURTHER RESOLVED, that the Redistricting Advisory Board shall advise the City Council and City Manager on boundaries to be established for redistricting within the City of San Diego and hold public meetings as may be necessary to receive input for such purpose.

BE IT FURTHER RESOLVED, that the following appointments by the Mayor of The City of San Diego to serve as members of the Redistricting Advisory Board be and the same are hereby confirmed:
