A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO AMENDING THE PROCEDURES FOR THE FORMATION OF A PROJECT AREA COMMITTEE FOR THE CENTRAL IMPERIAL REDEVELOPMENT PROJECT AREA BY REDUCING THE MEMBERSHIP ON THE PROJECT AREA COMMITTEE AND APPROVING SUCH REDUCED MEMBERSHIP AS A REPRESENTATIVE PROJECT AREA COMMITTEE.

WHEREAS, the City Council of The City of San Diego (the "Council") by Resolution No. R-274669, adopted the Procedure for Formation of Project Area Committee for the Central Imperial Redevelopment Project at its October 31, 1989 meeting; and

WHEREAS, an election was held in the community in which the Central Imperial Redevelopment Project is located on November 30, 1989 and January 11, 1990 for the purpose of electing members to serve on the project area committee; and

WHEREAS, the election was conducted after notice and according to established procedures set forth within the documents approved by the Council and a representative from the City Clerk's office attended the election to ensure its validity; and

WHEREAS, the residents, businesses and community organizations within the Central Imperial Redevelopment Project Area were unable to elect twenty-one (21) members to the project area committee in accordance with the established procedures set forth within the documents approved by the Council, but instead were able to elect only fifteen (15) members; and

WHEREAS, the Council now desires to amend said procedures to reduce the size of the membership on the project area committee to fifteen (15) members; and

WHEREAS, the elected members of the project area committee have submitted to this Council information establishing the qualifications of each person and of the project area committee; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That an amendment to the Procedures for the Formation of the Project Area Committee be approved and the size of the project area committee set forth in Section 600 of the Procedures be amended to reflect a reduction in membership size from twenty-one (21) members to fifteen (15) members.


2. That the Central Imperial Redevelopment Project Area Committee consisting of the fifteen (15) persons named on the list of Project Area Committee members attached hereto as Exhibit A and incorporated herein by this reference is hereby approved as constituting a representative project area committee.

3. That the Council hereby concurs that the election results are valid and binding in accordance with the procedure so adopted by Resolution No. R-274669, as modified by this Resolution.

4. That the Redevelopment Agency of The City of San Diego is hereby directed to consult with and obtain the advice of the project area committee concerning those policy matters which deal with the planning and provision of residential facilities or replacement housing and other matters which affect the residents

of the Project area while preparing a Redevelopment Plan and for a period of three (3) years after adoption of the Plan.
